#### **6.3 Directors' Reports**

Reynolds: The County held had workshop to discuss the new location of the firehouse on February 27<sup>th</sup>, wherein four sites were determined; the County yard, Bean Hollow Road, the current site, and at the high school. This meeting was well attended and engaged the community for input. The Mushroom Farm held an interesting and worthwhile quinoa growing workshop. The County Ag Commissioner held a Mountain Lion and Livestock Workshop with interesting information about mountain lion behavior. Pescadero has seen a great deal of flooding and the road has been impassable a lot of the time.

March 2016 Minutes

Kossy: Weed Management Area Committee held a meeting, wherein a main topic of discussion was the PG&E pipeline repairs and a restoration plan for disrupted serpentine grassland. PG&E's multihundred page document is available for comment, should the RCD wish to contribute a comment.

Nelson: The RCD provides non-regulatory technical assistance to landowners, and would typically provide comment or advocate for outcomes when relevant to the ability of the RCD to do its work. An appropriate comment might be to remind PG&E of the RCD's role and resources, and to encourage them to make use of the RCD.

Watt: TomKat Ranch is coordinating a zero-waste program, and is exploring this idea in its neighborhood and community. Watt is discovering that many surrounding farms and ranches don't know how to comply with waste regulations. Should the County begin to enforce its regulations, many farms would be surprised by the regulations that exist. Watt will share information with Nelson.

Glauthier: Met with Nelson and Moldovan about the RCD's Cost Allocation Plan to be proposed to the Board in March, staff billing rates, and the upcoming fiscal year's budget. A cost allocation plan delineates overhead costs for generating proposals. Glauthier will be absent from the board meeting in April but will rejoin in May.








### Objectives

## What are we testing?

Pollutant	Potential Sources	Effects
Fecal Indicator Bacteria (E. Coli, Enterococcus)	Feces of warm blooded animals	Indicator for human pathogens
Nutrients (Nitrate, Orthophosphate)	Fertilizers, pesticides detergents, human waste	Eutrophication/harmful algal blooms-ecosystem and recreation impacts
Metals (Copper, Zinc, Lead)	Brake pads, tires, streets, industrial waste, roofs, gutters, downspouts	Impacts to aquatic organisms and human health
Total Suspended Solids	Construction sites, erosion, agricultural runoff	Sedimentation, respiratory effects in organisms




### E. coli 2015




### Enterococcus 2015










### Copper (Cu) 2015










# Zinc (Zn) 2015











# Lead (Pb) 2015










### Nitrate (NO3-N) 2015











### Orthophosphate (O-PO4) 2015










### Total Suspended Solids 2015









# SMC Results Summary

### → 2015 summary (13 sites):

Bacteria: 100% exceedance

O-PO4: 85% exceedance

Cu: 23% exceedance (West Point, Vassar, Vallemar)

Zn: 15% exceedance (West Point, Vassar)

Pb, NO3-N, TSS: 0% exceedance

### 2008-2015 summary (9 historic sites)

Bacteria: 100% exceedance

O-PO4: 67% exceedance. El Granada every year

Cu: 47 % exceedance. Vassar every year

Zn: 16% exceedance. West Point exceeded most often

TSS: 2% exceedance

Pb, NO3-N: 0% exceedance



### Historic Location Summary

- Metals & Nutrients: Lower nitrate and metals but similar O-PO4 to Monterey and Santa Cruz County
- Bacteria: SMC likely similar to Monterey County and Santa Cruz County?
  - Different detection limits



### Next Steps

- Implement Best Management Practices
  - Vegetated swales, permeable surface, education/outreach
- Continue program
  - 7 years in San Mateo vs 16 years in Santa Cruz and Monterey Counties
  - Make comparisons over time
- Multi-year funding for cost-effectiveness

### Executive Director Report March 2016

#### Select Program and Project Updates

#### Fitzgerald Pollution Reduction Project

The final project report is available on the RCD website at <a href="http://www.sanmateorcd.org/fpr-report/">http://www.sanmateorcd.org/fpr-report/</a>. It summarizes efforts to reduce pollution entering the James V. Fitzgerald Marine Reserve by educating and recruiting Montara and Moss Beach residents to implement best management practices in the watershed. It provides information about the work that was completed, lessons learned, and potential follow-up activities. The project was completed in partnership with the landowners and San Mateo County and funded by the State Water Resources Control Board.

#### Select Funding Updates

#### Alpine Creek Fish Passage Project

The RCD submitted an application to the Fisheries Restoration Grant Program of the CA Department of Fish and Wildlife for \$1,018,721 to remove the barrier to fish migration posed by the Pescadero Creek Road crossing on Alpine Creek (a tributary to San Gregorio Creek). If funded, the project will provide fish unimpeded access to 3 miles of habitat upstream, repair the stream channel, and improve the hydrology downstream of the road crossing. Funding for planning and design was provided by the Coastal Conservancy through the Integrated Watershed Restoration Program (IWRP).

#### Slender False Brome Eradication at Wunderlich County Park

The RCD submitted a grant proposal in partnership with County Parks to work collaboratively with them, the Weed Management Area, and the Open Space District on a two-year program to eradicate Slender False Brome at Wunderlich County Park in Woodside and beyond. The request for \$45,100 was submitted to the California Department of Food and Agriculture for a US Forest Service State and Private Forestry Weed Control grant.

#### Administration and Operations

#### New director

We welcome Kevin Watt as the newest member of the RCD Board of Directors. He and his wife own and operate Early Bird Ranch, a small, family-run farm in Pescadero that uses integrated sustainable production models that emulate natural systems to raise chicken, pork, rabbit, and eggs and reduce the need for off-farm inputs. In addition to farming, Watt is the Integrated Land & Livestock Manager at TomKat Ranch Educational Foundation in Pescadero and serves on the "NextGen" committee at

Peninsula Open Space Trust. He received his Master's Degree in International Affairs from the UC San Diego School of Global Policy and Strategy.

#### **Finances**

Staff and the Finance Committee (Director Glauthier) are working on the FY '17 budget. A draft proposed budget will be brought to the full board as a discussion item during the May 2016 meeting and as an action item for the June 2016 meeting.

Staff and Glauthier have also been working on a revised Cost Allocation Plan (CAP) for the RCD, which will serve as the basis for billing rates and other strategies to recover overhead and otherwise earn revenue to pay for the true costs of delivering RCD programs. The CAP will be brought to the Board as an action item during the May 2016 meeting.

Taking a look at the financial statements for February 2016, one can see that the RCD has been a growing organization. Based on total assets, the RCD has grown from a \$300,000 organization in 2003 to a \$1.5 million organization today. During that time period, the RCD did \$9.6 million dollars of work.

- April 1- TomKat Ranch and the RCD are co-hosting a workshop entitled "Ranching for Profit" at TomKat Ranch. The workshop will be led by Dave Pratt of Ranch Management Consultants, Inc. He is a leader in the field of business planning for profitable ranching.
- April 12- Staff will present to the San Mateo County Board of Supervisors about the RCD. Directors and other interested individuals are encouraged to attend.
- April 26 (possible date)- The State Science Panel will present the results of their work to better understand the Pescadero marsh and lagoon. The RCD is helping to coordinate the meeting. Location, exact date, and time are to be determined.
- April 27- The Spring Meeting of the Central Coast Region of RCDs will be held in Morro Bay. Directors are encouraged to participate. Please let me know if you would like to attend.
- May 5- RCD will host California Department of Fish and Wildlife at a location to be determined regarding the impacts of the drought on Coho salmon in Pescadero, voluntary water conservation and potential Department enforcement actions.
- No date yet- RCD staff and San Mateo County Farm Bureau are coordinating and will cohost a workshop for farmers on new water reporting requirements for irrigated lands.
