1 Call to Order

Rich called the meeting to order at 6:41 p.m.

2 Introduction of Guests, Committee, and Staff.

Kellyx introduced Karissa as a new staff member who grew up on a farm in San Luis Obispo County and most recently worked at the San Francisco Bay Regional Water Quality Control Board. Karissa discussed her background and answered questions. Directors introduced themselves and gave their background as well.

3 Public Comment.

4 Approval of Agenda

• Jim moved to approve and Roxy seconded. Agenda approved unanimously.

5 Consent Agenda

• Roxy moved to approve and Jim seconded. Consent agenda approved unanimously.

6 Discussion Items

- 6.1 FY 2008/2009 Audit Update.
 - Renee advised that a draft audit will be finished by the October board meeting. We have the option of discussing the audit report by phone with Michael, a partner at RJ Ricardi. The results of the audit look good.

6.2 Staff Reports

- Daniel Mountjoy's wife has passed after a long battle with cancer.
- Staff shared updates about the office reorganization and asked the Board for labor to move furniture. Rich offered to help provide some.

6.3 Executive Director Report.

- Ag Water Quality will be wrapped up this quarter.
- The Blue Circle will be held on September 22, 2010 and will provide the results of the It Takes a Community to Care for a Watershed grant as well as the Ag Water Quality grant.

- Cooperative Conservation Partnership Initiative (CCPI) will be wrapping up this quarter. The remaining task is outreach in Spanish to farm workers regarding implementation of irrigation efficiency projects, coordinated by the Farm Bureau.
- Pillar Point Harbor fecal pollution project The State Water Resource Control Board will review our request for additional funds to make the project whole on October 18, 2010. The San Mateo County Harbor Commission awarded \$15K to finish the circulation study.
- It Takes a Community to Care for A Watershed The volunteers completed the year of monthly data collection in six mid-coast creeks. The final workshop will take place at the Blue Circle.
- Pilarcitos Watershed Plan –DFG will be completing stream surveys in the next few weeks. There will be a Workgroup meeting on September 21st. We are working with SFPUC and others to set up multiple year funding for the stream gage and the RCD's role overseeing the Plan.
- San Gregorio Watershed Enhancement Program The watershed plan is completed. The focus now is on implementing its recommendations. We have \$40K from US Fish and Wildlife Service to implement some of the recommendations, including eradication of purple loosestrife in Reflection Lake.
- *Hypericum canariense* This is a dangerous weed that supplants coastal scrub habitat at an alarming rate and is concentrated on a single private property near Gazos Creek. The landowner has agreed to work with us on it.
- Watershed Coordinator Grant Kellyx and Marti are working on a grant proposal to pay the salary for a watershed coordinator for 3 years.
- Pescadero Total Maximum Daily Load (TMDL) outreach The next workshop should happen in October.

6.3 Planning for Executive Director Maternity Leave

- October will be Kellyx's last board meeting until March. At the next Board meeting we will have any action items relating to maternity leave. Rich has signing authority and Roxy is willing to serve as Acting Executive Director, as she did before.
- Rich, Roxy, and Neal's terms expire in November. Kellyx will look into the issue with the Board of Supervisors and report back.
- Upcoming Board meetings will be December 16th and February 17th.

7 Action Item

7.1 Resolution 2010-1: Authorizing Entering Into a Proposition 84 Areas of Special Biological Significance Financial Assistance Agreement with the State Water Resources Control Board and Designating a Representative to Sign the Agreement, and Any Amendments Thereto.

• The Livestock and Land Program is hosted by Ecology Action in Santa Cruz as a partnership with the RCD of Santa Cruz County. The program assists with water quality improvement on livestock and equestrian operations. These funds were awarded to expand the program to Monterey and San Mateo counties. We are the grant recipient, as only public agencies could apply for the grant, but we are subcontracting to Ecology Action for much of the grant administration. Projects have to be in designated Areas of

Draft Minutes September 16, 2010 p.2 of 3 Special Biological Significance (ASBSs). In our county, this includes the Fitzgerald Marine Reserve Critical Coastal Area and Ano Nuevo.

- Jim moved to approve Resolution 2010-1. Roxy seconded. The resolution passed unanimously.
- 7.2 <u>Resolution 2010-2: Authorizing a Proposal for a Proposition 84 2010 Watershed</u> <u>Coordinator Grant and Entering into a Grant Agreement with the State of California</u> <u>Department of Conservation.</u>
 - Marti discussed what the submission of this proposal requires.
 - Jim moved to approve Resolution 2010-2. Roxy seconded. The resolution passed unanimously.
- 7.3 CARCD Resolution: Directing CARCD to promote the RCD mission to private and public funders, other resource conservation organizations, and policy makers and to work with those entities to define and promote effective and collaborative roles between the RCD's and their conservation partners' goals and objectives.
 - Kellyx worked with the RCD of Santa Cruz County (RCDSCC) to draft this proposed resolution for the CARCD conference. It has already been approved by the board of RCDSCC.
 - Kellyx described that newer environmental organizations are increasingly demonstrating interest in doing resource conservation work that RCDs have historically done in areas historically served by RCDs and that RCDs need to remain relevant and visible and improve collaboration with other resource conservation groups.
 - Jim moved to accept the CARCD resolution. Roxy seconded. Unanimously approved.

The District agrees and further does authorize the aforementioned representative or her designee to execute any other documents required for administration of said agreement and to certify that the District has and will comply with all applicable federal and state statutory and regulatory requirements related to any financial assistance funds received.

Whereas the San Mateo County Resource Conservation District is a Special District organized under Division 9 of the California Public Resources Code with an original petition granted on July 1, 1939; and
