## 4. SELECTION OF AGRICULTURAL WATER QUALITY GRANT RECIPIENTS:

- The contract with the State Water Resources Control Board ends in March. The RCD applied for an extension. There are three scenarios: (1) The contract is not extended, in which case cover crops can be installed with minimal water quality monitoring, (2) the contract is extended through June, in which case monitoring can be done but will be concurrent with reporting and other grant requirements, or (3) the contract will be extended through the end of the calendar year.
- Based on current projections, funds remain for implementing an additional season of cover crops in contract with the Farm Bureau.
- Many of the projects funded by the grant were impossible to monitor for water quality because they implemented practices that reduced or eliminated runoff. Cover crops would have provided much of the water quality monitoring opportunities but they were not monitored last year. This year should provide that opportunity, especially if 75% coverage in fields is not required before monitoring will take place.
- Staff would like to spend as much of the grant funds as possible and would need to act quickly on the cover crops if the committee selects the project.
