# Minutes of the Regular Meeting of the Board of Directors May 18, 2017 Location: RCD Office

Glauthier called the meeting to order at 4:01 pm.

## 3 Public Comment

Howard spoke about Consent Agenda Item 5.8. The NRCS will be moved to a new department. It is unclear what this means on a large scale, but there will be no immediate cuts to staffing. The NRCS hired a new engineer who will be joining the office soon, and living in Half Moon Bay. He has NRCS experience through the Pathways program.

#### 6 Discussion Items

## 5.5 FY 2016 Audit Report

- Glauthier noted a material weakness. Moldovan explained that there was a delayed payment with Paychex which was not on books for the 2015 calendar year, which affected the previously approved balance sheets.
- Board approved the audit unanimously.

## **5.6** Reserve Policy

- Discussion focused on: establishing a reserve has been a goal of the RCD for many years; the current plan does not obligate the RCD to a certain amount, but is more focused on process; a goal reserve amount. Glauthier praised the policy, stating that it is ambitious.
- Board approved the policy unanimously.

# **6.1** Executive Director report

- There was discussion about the status of ponds projects and that Joe Issel, RCD Natural Resource Specialist, will be taking the San Mateo County Food System Alliance on a site visit to Repetto pond next week.
- There was discussion about the Department of Conservation capacity building grant., with professional development being the priority.

# 6.2 Directors' report

- Kramer No updates.
- Reynolds Praised the Butano Creek Floodplain Restoration Project, noting the new presence
  of trout pools. Looking forward to in depth explanations of the project, possibly at the June
  community meeting.
- Watt Commented on the TomKat carbon farm plan, a partnership between the RCD and TomKat, which he noted as ambitious and going well. TomKat is also working with the RCD to plan the August RCD Regional Meeting. Watt discussed the state's Healthy Soils Initiative, noting that it is exciting to have government recognizing the part soils can play in greenhouse gas mitigation.
- Kossy May 23<sup>rd</sup> is the Weed Management Area's Picnic in the Weeds. Those involved will see
  restoration sites and infested areas. Cleopatra Tuday, the new RCD staff member coordinating
  the Slender False Brome project, will join so that she can meet those involved in the WMA.

- Kossy noted the engaging and inclusive tone in recent RCD Facebook posts. Kossy offered to assist with the Central Coast Regional RCD meeting.
- Glauthier Plans to attend this weekend's State Democratic Convention. If he has an
  opportunity, he will reinforce the benefits of funding for the Pescadero Marsh project. Glauthier
  would like to host a social event for both Board members and staff. He will work with Carroll
  to plan it.
- **6.3** Board will review and finalize calendar of topics for upcoming year of Board meetings
  - The Board and Nelson discussed topics the Board wanted to focus on for this year, and created the attached draft schedule.
- **6.4** Board will discuss meeting in Pescadero
  - The Board discussed holding a meeting in Pescadero to be more accessible to people in the community and decided to do that at a future date when the Board agenda includes Pescadero projects. The board will return to this topic in June.
- 6.5 Board will determine contribution to 401K by RCD for employees eligible in calendar year 2016
  - Based on 2016 calendar year financials, Moldovan recommended a 3-4% contribution for eligible employees. The Board discussed the contribution.
  - Kossy made a motion for a 4% allocation. Watt seconded the motion. The motion passed unanimously.
- 6.6 Board will discuss Draft FY 2018 Financial Budget
  - Nelson provided an overview of the proposed draft budget, a recent history of variances between budgeted and actual end of year net balances, and current efforts to develop a conservative budget. Directors discussed.

## 7 Closed Session

- **7.1** Public Employee Performance Evaluation. Per Government Code Sec 54957, Board discussed the performance of the Executive Director.
  - The Board reported satisfaction with the positive performance of the Executive Director.
