- Reynolds expressed interest in what will be learned from the Butano floodplain studies and sedimentation in the Butano floodplain. Has noticed new gullies and washouts forming similar in size to the Cloverdale project site. Suggested looking into studies or modeling of the upper watershed. Proposal from Nelson to add sedimentation as a potential study session topic to Board calendar.
