# Minutes of the Regular Meeting of the Board of Directors June 21, 2018 4:00 pm - 6:00 pm Location: RCD Office

#### 5 Convene Open Session and Report on Closed Session

Open session was called to order at 5:14 p.m. Glauthier reported that no actions were taken during closed session.

#### 6 Introduction of Guests and Staff

Directors, staff, and Bill Schwegler, Board Member from Pacifica Land Trust, introduced themselves. Schwegler noted that the Pacifica Land Trust has just completed the Pedro Point Trail and is looking to take on more projects as well as get to know the other land stewardship agencies on the San Mateo coast.

#### 7 Public Comment

Glauthier mentioned to Howard that the Farm Bill had passed in the house and asked if he had any comments. Howard said his approach was to wait and see.

#### 8 Consent Agenda

- **8.1** February 15, 2018 Draft Regular Minutes
  - Item 8.1 was pulled off of consent for discussion.
  - Nelson handed out revised Financial Statements for April 2018 (attached). The accountant has reconciled all transactions through April, hence the April statements as opposed to May.
  - Nelson talked through the differences in the revised April financial statements.
  - Glauthier stated that it looks like the RCD was paying some vendors before
    having received the money from funders. Nelson confirmed and described the use
    of bridge loans and cash reserves to pay vendors where there was low risk of not
    being reimbursed. This helps mitigate the issue of late payments dissuading
    venders from bidding on projects.
  - Nelson handed out financial statements for the fiscal year to date and explained that, 9 days short of a full year. The numbers are very close to what was budgeted for the year, and the RCD will end up with a larger net because of the accrual basis.
  - Glauthier stated that these are a much better snap shot and that the Board should not approve the April finances until this additional information is included.

#### 9 Regular Agenda

- 9.1 Approval of Lease at 80 Stone Pine, Half Moon Bay, California
  - Discussion included:
    - The space is double the size of what the RCD currently leases and can help the RCD better be a hub for meetings of local groups and collaboratives.
    - It has windows and natural light, which the current space does not, overlooking trees and vegetation.
    - The layout better fosters collaboration as all of the staff will be on one floor around a central space.
    - It is wheelchair accessible.
    - It has showers, important for field staff, which are wheelchair accessible.
    - It will be a significant new expense because of the increase in price per square foot and the increase in square feet.
  - Glauthier moved to authorize the Executive Director to negotiate the terms of the lease, including a better exit clause, and further authorizes Nelson to continue negotiating the terms of the lease in concert with building the Fiscal Year 19 Budget. Kossy seconded the motion. Motion passed unanimously.
  - Nelson stated that the RCD will welcome Board members and their friends to help box things up. Staff is concerned about how to pack with their current work load and not having a grant to bill their time to pack.
- 9.2 Board will consider contracting with Amah Mutsun Land Trust for the Quiroste Valley Cultural Preserve Vegetation Management Project.

- There was discussion about whether all permits had been secured, the value and benefits of the project, and support for State Parks working at the forefront and across boundaries to give indigenous peoples access to their ancestral lands.
- Reynolds moved to approve contracting with the Amah Mutsun Land Trust for the Quiroste Valley Cultural Preserve Vegetation Management Project. Kossy seconded. Motion passed unanimously.

#### 9.3 Directors' Reports

- Kossy announced the Weed Area Management Area meeting on July 17.
- Reynolds walked the creek near the flood plain restoration project. He noticed some
  major changes and looks forward to discussing what he saw with the RCD staff.
  Nelson stated that Fisher had recently defended his thesis on this flood plain and she
  had asked him to present to the Board at an upcoming meeting.
- Glauthier stated that he and Reynolds met with the Executive Committee of the San Mateo Farm Bureau to discuss how the Farm Bureau and RCD can better work together.
- Nelson asked Reynolds if he would like to comment on the last Pescadero Municipal Advisory Council meeting which included the Total Maximum Daily Load, regarding water regulations, on the agenda. Reynolds stated that he thought Nelson did an excellent job presenting and he was happy that Nelson asked for people to consider becoming an RCD Board Member as she anticipated an opening soon.
- Nelson reminded the group the next meeting of the Board was June 27, 2018 in Pescadero at the La Honda Pescadero Unified School District Community Room. Glauthier requested slides of the project be presented prior to the start of the meeting.
