2019 Urban Farm Conservation Technical Assistance & Mini-Grant Program

Application Packet

Grant applications are due July 12, 2019

San Mateo Resource Conservation District (RCD) is offering assistance to urban farms (including community and school gardens) in San Mateo County, intended to support improvements that will enhance soil, conserve water and build conservation as well as habitat, both on-site and in the surrounding community. RCD will help awardees to develop a conservation plan and help move the project towards implementation. The funding for this program is through the National Association of Conservation Districts.

ELIGIBLE PRACTICES

Grants may cover the following types of activities:

- Conservation and habitat plantings: e.g. cover crops, hedgerows, windrows, pollinator gardens, bee and owl boxes, drought tolerant or native plantings
- **Soil health building activities:** e.g. compost acquisition, compost systems, vermiculture systems, cover crops, mulching
- Water conservation (quantity and quality) activities: bioswale, filter strips utilizing native, drought tolerant or other appropriate plantings, straw wattles for storm drains, mulching, cover crops

All awardees that receive funding must include informational signage explaining the purpose of conservation practice. The RCD will cover the cost of the signage separate from funds for implementation.

Only direct costs are eligible for reimbursement, if grantee receives funding.

ELIGIBILITY

Eligible applicants include urban farms, including community and school gardens. The site must be actively in production and must be in an urban area of San Mateo County. Special consideration will be given to farms serving low-income communities.

SCORING CRITERIA

Proposals will be reviewed and scored by a panel of staff from San Mateo RCD, UC Cooperative Extension and San Mateo County Office of Sustainability. Scoring of proposals will take into account eligibility, need, community engagement, population served, and potential conservation practices to be incorporated into farm management.

AWARD

The technical assistance provided by the RCD to help with design and implementation is provided by the RCD at no cost to the applicant. The RCD may fund or partially fund implementation of conservation practices depending on the practice, cost, and available resources of the urban farm.

AWARDEE REQUIREMENTS

Awardees who receive funding must implement their conservation practices by January 31, 2020, allow the RCD to conduct a post-implementation site visit to verify that the practice was implemented, and submit short final report and budget (templates will be provided).

WHAT COSTS WILL THE GRANT COVER?

Covered

- Materials and supplies for the project
- Equipment rentals
- Wages or salaries for labor (no more than 50% of total grant funds may be spent on labor)

Not Covered

• Farm equipment or supplies not directly related to the project (e.g., rototiller, tractor implement, computer etc.)

IMPORTANT DEADLINES

- Proposals due: **July 12**, **2019 5pm**
- Applicants notified: July 26, 2019
- Projects that receive funding must be completed with a final report due: January 31, 2020 form will be provided
 - Final grant payment will be disbursed within 30 days of receipt of a final invoice.

Funds will be reimbursed after submission of invoice/s with attached receipts. For those applicants that do not have the ability to cover the up-front costs, the RCD may be available to make purchases of supplies and materials in lieu of a reimbursement.

Grantees who are unable to carry out their proposed projects by the end of the grant period may be required to return funds.
