Minutes of the Regular Meeting of the Board of Directors June 18, 2020 4:00 pm - 6:00 pm via Zoom teleconference

1. Call to Order

Kossy called the meeting to order at 4:05 p.m.

2. Approval of Agenda

Glauthier moved to approve the agenda, Etherton seconded. Motion passed unanimously.

3. Introductions of Guests and Staff

All in attendance introduced themselves.

4. Public Comment

Silverstein stated that Thrive Alliance had launched a study into single use plastics; Nelson noted that Noah Katz, the RCD's Water Quality Program Manager, had participated in the conversation.

5. Consent Agenda

Glauthier moved to approve the consent agenda, Reynolds seconded. Motion passed unanimously.

6. Regular Agenda

- **6.1** Board will consider Resolution 2020-4: In appreciation of and Gratitude for the Contributions of Chris Spohrer, Tim Hyland, Ryan Diller, Tim Reilly, and Portia Halbert.
 - Nelson noted the RCD's appreciation for the leadership of Spohrer and his knowledgeable and forward-thinking team, who understand the mission of the RCD and are dedicated problem-solvers and highly collaborative partners.
 - Spohrer thanked Nelson and noted, while California State Parks appreciated the recognition, they appreciated the partnership more.
 - **ACTION:** Glauthier moved to approve Resolution 2020-4, Etherton seconded. Motion passed unanimously.

6.2 Board will consider approval of Fiscal Year 2021 Budget.

- Glauthier noted revisions since the previous draft was reviewed by the Board. Nelson explained the change in net income to negative, the conservative assumptions in developing the budget, and that \$2.7 in Accounts Receivable is anticipated to offset the negative balance.
- Glauthier commented that the deficit reflected a budget 99.8% in balance.
- Kossy thanked staff for the user-friendly budget format; Nelson thanked Hodges for assembling input from staff to build the budget and for improving the efficiency of the process and quality of the budget.
- Etherton asked if the \$200K would still be coming in from San Mateo County; Nelson explained that the county passed a 2-year budget and that she was expecting the \$200K. She further noted that the county contributes \$200K and the RCD brings millions into the county.
- **ACTION:** Glauthier moved to approve the Fiscal Year 2021 Budget, Etherton seconded. Motion passed unanimously.

6.3 Diversity, Equity and Inclusion

- Nelson reported on what the staff DEI committee and general staff had been working on:
 - 1. The SCOTUS Ruling: 1964 Civil Rights Act's prohibition on sex discrimination in employment also effectively banned bias based on sexual orientation or gender identity had been discussed at a staff meeting and how that might come up in the work the RCD does.
 - 2. Nelson noted that conservation was a very white field and RCDs needed to create opportunities for people of color. The California Association of RCDs (CARCD) had convened a statewide network for RCD staff of color which Nelson hoped would have a direct conduit to the CARCD Board.
 - 3. Staff discussed the importance of paying interns, as unpaid internships limit access to who can apply.
 - 4. Staff is re-thinking recruitment and bid advertisements to ensure equity; Kossy expressed hope that the RCD would prioritize women and minority owned business when purchasing supplies. Silverstein noted that Peninsula Clean Energy had done a good job with their recently updated recruitment policy.
 - 5. Staff is working with Rancho San Benito, an organization helping farm workers become farm owners, through aid in business planning, carbon farming, addressing climate change in vulnerable communities. Staff has been asked to help assess residential water quality on San Mateo County's south coast.
- Etherton noted her appreciation of the staff's efforts and the RCD's recent statement in support of Black lives.
- Kossy recently participated in a webinar with Black birders via the Sequoia Audubon Society in response to the birder who had the cops called on him in Central Park.

She found it moving to hear from Black birders and how they had felt unsafe simply being in a neighborhood with binoculars.

- Nelson reported on the feedback received from the statement the RCD had released:
 - 1. It appears that only two conservation districts in the nation had put out a statement: San Mateo and Portland.
 - 2. 7-10 people unsubscribed immediately upon receiving the statement and one angry email was received.
 - 3. A large number of emails of gratitude were received.
 - 4. Nelson received phone calls from RCD staff of color from all over California, asking how they could get that level of support from their employers.
- Kaeser said how proud she was that the RCD made that statement. She found it concerning that other RCDs and organizations hadn't.
- Silverstein admitted that Thrive Alliance members are also predominately White and that they found it difficult to serve their community as a result of it. Etherton noted that it was important not to put the emotional labor onto the communities to tell organizations what to do.

6.4 Executive Director's report (see attached)

- Regarding the chipping events Kossy asked what happened to the chips; Nelson
 answered they could either be left on site or hauled to the green waste dump. Issel
 noted that they are often mixed with weedy material.
- Regarding Local Agency Formation Commission (LAFCO) Municipal Service Review Glauthier stated that LAFCO is missing the opportunity to tell the RCD's story and in doing so might make the case for expanding the district's boundaries and, therefore, possibly increase tax revenue.
- Glauthier thanked Nelson for her presentation at the San Mateo County Harbor District's Board of Commissioners meeting. He said she did a great job conveying what the RCD had been doing at Pillar Point Harbor for water quality.

6.5 NRCS report


• Jim Howard was unable to attend the meeting due to a conflicting work meeting regarding the NRCS' partnership with the Environmental Protection Agency.

6.6 Directors' reports

- Reynolds noted the success of the Butano Channel Dredge Project and the noticeable difference it had made on his property.
- Glauthier sent a letter to Congressman Garamendi, Congresswoman Speier, Senator Harris and Senator Feinstein regarding H. R. 7073, the "Special Districts Provide Essential Services Act" that would ensure RCDs would be eligible for the next round of federal assistance funding.
- Etherton noted that on the City of Brisbane's Council was voting on joining the Weed Management Area.
- Kossy stated that the California Invasive Plant's Facebook page was thriving and up to 6,000 members.

- Etherton noted she would not be at the August meeting because she'd be a new mom

Weed Management


- Slender false brome and Carex pendula treatment begins next month
