Minutes of the Regular Meeting of the Board of Directors April 15, 2021 3:00 pm – 6:00 pm via Zoom teleconference

1. <u>Call to Order</u>

Kossy called the meeting to order at 4:06 p.m.

2. <u>Approval of Agenda</u>

Glauthier moved to approve the agenda, Etherton seconded. Motion passed unanimously.

3. Introductions of Guests and Staff

All in attendance introduced themselves.

4. <u>Public Comment</u>

There was no public comment.

5. <u>Consent Agenda</u>

- Etherton noted the incorrect time on the Draft March 18, 2021 Minutes under agenda item 1. It was recorded as having begun at 4:00 p.m. instead of 3:00 p.m.
- Glauthier moved to approve the consent agenda as amended, Etherton seconded. Motion passed unanimously.

6. <u>Regular Agenda</u>

6.1 Forest Health and Fire Resilience Program updates by Sheena Sidhu, Program Manager (see attached)

- After the presentation there was discussion regarding the amount of time it takes to accomplish large scale fuel load reduction; the workload of building capacity, managing projects and developing innovative permitting tools, while engaging with the community; County efforts; and post-fire recovery efforts.
- 6.2 Board will consider recommendation Resolution 2021-2: Approval to Enter into Agreement with the California Wildlife Conservation (WCB) Board for the Little Butano Creek Streamflow Improvement Project, Butano State Park.

- There was discussion about the project benefits to streamflow and upcoming contractor selection.
- **ACTION:** Glauthier moved to enter into agreement with WCB, Etherton seconded. Motion passed unanimously.

6.3 Executive Director's Report

• Nelson provided program, project, and administrative updates. The report has been lost due to a crashed computer hard drive.

6.4 NRCS report

- Howard reported:
 - NRCS has taken on the lion's share of the work for the USDA's Farm Service Program; three of which had been implemented in San Mateo County after the CZU Fire to aid in the repair of ponds, tanks, and fencing.
 - Close to approving a National Water Quality Initiative agreement with RCD to address sediment in San Mateo County watersheds; Phase 1 was Noah Katz, San Mateo RCD Water Quality Program Manager, writing an assessment of the watersheds.
 - NRCS had received a lot more applications for the Environmental Quality Incentives Program (EQIP) across California. NRCS was requesting an additional \$47 million in California.
 - The new USDA Administrative was putting COVID protocols in writing and taking a conservative approach to reopening offices.
 - Howard is also joining the Cascade Council; an advisory group formed to assist with the path of Cascade Ranch regeneration project.

6.5 Directors' reports

- Glauthier reported on his work with Local Agency Formation Commission (LAFCO) and State Board of Equalization on RCD's boundary expansion.
- He was glad to hear the Fiscal Year 2022 Budget process was underway.
- He asked about the plan to address eucalyptus in El Granada. Nelson noted County Parks prioritization process and RCD staff prioritization of the Quarry Park area.
- o Berkeley Labs uses the acronym IDEA (Inclusions, Diversity,
- o Equity and Accountability) as opposed to DEI (Diversity, Equity and Inclusion)
- Etherton thanked Glauthier for his work on LAFCO and noted her excitement for the upcoming DEI training.
- Kossy reported that she had traveled through California and found it difficult to see the scars and wounds on lands in the state; it made her that much more proud of the RCD.
- Keener reflected on the water quality relationship between San Pedro Creek and Linda Mar Beach. He looks forward to RCD staff support on the issue.



Prescribed fire and eradication




SFPUC Rx Burn

- Dual goals of restoring historic disturbance regimes (low moderate intensity fire) and developing strategic fuels reduction in WUI areas









Huddart & Wunderlich County Parks

400 acres over two parks Implementation starting this summer








Girl Scout Camp Butano and Butano State Park




Quiroste Valley Cultural Preserve Vegetation Management

- To-date SMC funds have been leveraged to bring in \$4.1M in additional Forest Health and Fire Resiliency funding to the county




Eucalyptus management



RESOLUTION 2021-2

APROVAL TO ENTER INTO AGREEMENT WITH THE CALIFORNIA WILDLIFE CONSERVATION BOARD FOR THE LITTLE BUTANO CREEK STREAMFLOW IMPROVEMENT PROJECT, BUTANO STATE PARK

WHEREAS, the San Mateo Resource Conservation District is a Special District organized under Division 9 of the California Public Resources Code with an original petition granted on July 1, 1939;

WHEREAS, the San Mateo Resource Conservation District is defined in Section 3501 of the Government Code as a public agency;

WHEREAS, funds were made available to the Wildlife Conservation Board through the Water Quality, Supply, and Infrastructure Improvement Act of 2014 (Proposition 1) for projects that enhance stream flow;

WHEREAS, San Mateo Resource Conservation District intends to improve water distribution infrastructure and create 100,000 gallons of water storage at Butano State Park to improve water security for park operations and enhance streamflow in Little Butano Creek;

WHEREAS, the California Wildlife Conservation Board may encumber \$2,636,207.78 through the Stream Flow Enhancement Program for the San Mateo Resource Conservation District to implement the Little Butano Creek Stream flow Improvement Project, Butano State Park;

WHEREAS, the California Wildlife Conservation Board requires a resolution from the governing body of the grant recipient authorizing its designee to sign a financial assistance agreement, and any amendments thereto;

NOW THEREFORE BE IT RESOLVED that the San Mateo Resource Conservation District Board of Directors hereby:

- 1. Approves the filing of an application for funding from the Wildlife Conservation Board;
- 2. Authorizes its Executive Director to conduct negotiations, execute, submit, and sign all documents including but not limited to applications, agreements, amendments, payment

requests, and other documents which may be necessary for the completion of the proposed project;

- 3. Certifies that the Resource Conservation District will comply with all federal, state and local environmental, public health, and other appropriate laws and regulations applicable to the project and will obtain or will ensure that the other project partners obtain all appropriate permits applicable to the project; and
- 4. Further commits to the terms and conditions specified in the grant agreement.
